**CREDIT FOR CONTRIBUTIONS TO QUALIFYING CHARITABLE ORGANIZATIONS**

Arizona Revised Statute §43-1088 provides a non-refundable income tax credit for donations made to qualifying charitable organizations, commonly known as “Credit for Contributions to Qualifying Charitable Organizations.” River Fund, Inc. has been certified by the Arizona Department of Revenue as a “Qualifying Charitable Organization.” This means that every dollar contributed by Arizona taxpayers to the River Fund through the *Credit for Contributions to Qualifying Charitable Organizations* program will be utilized in our Bullhead City, Fort Mohave, Golden Shores, Golden Valley, Mohave Valley and Topock service area to assist individuals and families in crisis. It also means that **annual contributions up to \$470 for an individual and \$938 for married couples can be fully deductible as of September 2024!**

River Fund has directly impacted thousands of lives by helping to overcome personal emergencies and crisis hardships as well as grants for other local non-profit agencies including food banks, boys and girls clubs, youth sports, senior meals on wheels and more. The Arizona *Credit for Contributions to Qualifying Charitable Organizations* program allows your tax dollars to be used locally in support of River Fund programs and services that result in positive outcomes from unexpected hardships.

Remember: The maximum credit for contributions made to River Fund through the tax credit program is four hundred seventy dollars (\$470) for single and nine hundred thirty-eight dollars (\$938) for married taxpayers. The deadline is on or before April 15<sup>th</sup> of each year and may be applied to the current or preceding taxable year and is considered to have been made on the last day of that taxable year.
